- 1. Please bring two (2) fully completed copies of this Petition to the Register of Wills.
- 2. ORIGINAL DEATH CERTIFICATE must accompany this form.
- 3. \$25.00 FILING FEE (cash or check) must accompany this filing.
- 4. Must present VALID PHOTO I.D.
- 5. This Affidavit can only be presented if <u>sixty (60)</u> days has elapsed since the date of death.
- 6. This Affidavit CANNOT BE USED for Settlement of a Small Estate under 20 Pa. C.S.A. §3102.
